

PRS Italy Athlete Qualification Standards for International events.

In the near future, Italian shooters with PRS Italy membership could be called to be part of a PRS Italy National Team to participate in International events, following the main criteria that will be taken into consideration.

Rimfire 2025/2026 Qualifications

1. Must shoot and submit scores of a minimum 5 PRS Rimfire style matches during the qualification period (January 1, 2023 to December 31, 2024).
2. If the International event will take place in 2025, in addition to the 5 competitions in the two-year period 2023/2024, the shooter must also have completed 3 competitions in the current year.
3. If the International event will take place in 2026, the qualification period will be the two-year period 2024/2025 plus 3 competitions in the 2026.
4. Matches must have 25 shooters at a minimum.
5. At least two matches must have farthest target at a minimum of 200 meters in distance.
6. Matches must have a minimum of 8 stages and 90 rounds.
7. At least three matches must be different locations/ranges.

Exception: The only instance in which you could count two matches from the same venue, would be if the PRS Italy Championship National Finale and a match of a National Championship were at the same venue.

8. One match of each year must be a two day PRS Italy Rimfire National Championship Finale (match count as a single match)
9. Competitions held in other Nations must have the same criteria and be part of the respective National Championship e/o Regional Finale.
10. If provided for by the rules of the event, shooters may participate in their respective Division/Category:
11. **Senior Category:** Anyone turning 55 years or older at any point in the current season is eligible to shoot in the Seniors Category in addition to their PRS Division for the duration of the season. Age verified by birthdate on a government issued ID.
12. **Lady Category:** All female shooters are eligible to shoot in the Ladies Category in addition to their PRS Division. Gender as listed on a government issued ID, “female” being the only acceptable gender for this category.

13. **Junior Category:** Anyone 18 years old or younger at any point in the current season is eligible to shoot in the Juniors Category in addition to their PRS Division for the duration of the season. Age verified by birthdate on a government issued ID.

14. **Military/LE Category:** Any shooter who is a full time Active-Duty Service Member or Full Time LEO is eligible to shoot in the Mil/LE category in addition to their PRS Division. Part time National Guard/Reserve and Reserve Law Enforcement do not qualify to compete under the MIL/LE PRS Category. Contractor, civilian or specialty type employment for both MIL/LE will not qualify a shooter in the category.

15. **Shooter must have a DLR/PRS Italy Membership.**

16. Cutoff for qualification: December 31, 2025 The minimum percentage to be part of the National Team is 80% of the shooter score, for example:
Percentage points 588% with 7 competitions $588/7=84\%$

Above qualifications are subject to change/updates due to pending PRS/PRS Italy rule changes

Centerfire 2025 Qualifications

1. Must shoot and submit scores of a minimum 5 PRS Centerfire style matches during the qualification period (January 1, 2023 to December 31, 2024).
2. If the International event will take place in 2025, in addition to the 5 competitions in the two-year period 2023/2024, the shooter must also have completed 3 competitions in the current year.
3. If the International event will take place in 2026, the qualification period will be the two-year period 2024/2025 plus 3 competitions in the 2026.
4. Matches must have 50 shooters at a minimum.
5. At least two matches must have farthest target at a minimum of 900 meters in distance.
6. Matches must have a minimum of 8 stages and 80 rounds.
7. At least three matches must be different locations/ranges.

Exception: The only instance in which you could count two matches from the same venue, would be if the PRS Italy Championship National Finale and a match of a National Championship were at the same venue.

8. One match of each year must be a two day PRS Italy Centerfire National Championship Finale (match count as a single match)
9. At least three matches must be part of a PRO Series European Championship.
10. Competitions held in other Nations must have the same criteria and be part of the respective National Championship, Regional Finale, PRO Series Match.
11. If provided for by the rules of the event, shooters may participate in their respective Division/Category:

12. **Senior Category:** Anyone turning 55 years or older at any point in the current season is eligible to shoot in the Seniors Category in addition to their PRS Division for the duration of the season. Age verified by birthdate on a government issued ID.

13. **Lady Category:** All female shooters are eligible to shoot in the Ladies Category in addition to their PRS Division. Gender as listed on a government issued ID, “female” being the only acceptable gender for this category.

14. **Junior Category:** Anyone 18 years old or younger at any point in the current season is eligible to shoot in the Juniors Category in addition to their PRS Division for the duration of the season. Age verified by birthdate on a government issued ID.

15. **Military/LE Category:** Any shooter who is a full time Active-Duty Service Member or Full Time LEO is eligible to shoot in the Mil/LE category in addition to their PRS Division. Part time National Guard/Reserve and Reserve Law Enforcement do not qualify to compete under the MIL/LE PRS Category. Contractor, civilian or specialty type employment for both MIL/LE will not qualify a shooter in the category.

16. **Shooter must have a DLR/PRS Italy Membership.**

17. First three Italian shooters of the National Championship can participate to the PRS USA Finale.

18. Cutoff for qualification: December 31, 2025

19. The minimum percentage to be part of the National Team is 80% of the shooter score, for example:
Percentage points 588% with 7 competitions $588/7=84\%$
